## **4. Financial Report**

Stephen Richardson (Treasurer) gave an overview of the SCoS Accounts 2023/24:

- SCoS started the year with healthy financial position of £8290, thanks to the legacy funding from 10<sup>th</sup> Anniversary.
- We knew that we would need to raise funds throughout the year to maintain our work. SCoS raised funds at several events during the year: Chilean Commemorative event, HarMINDise Project, SASS Exhibition, Mumbles Churches together visit.
- Stephen thanked Alan and Marilyn Thomas who asked friends and family to donate to SCoS, instead of receiving presents for their Golden Wedding Anniversary. Their generous offer raised over £2500. Additional donations through [LocalGiving](#) and other one-off donations raised a total of £3983. We carried forward £13300.
- Our main expenses are Administrative costs, which are valued, especially as both our long-standing Secretary and Chair have stepped down in recent years, and we have been unable to replace them as yet. We also had spending on travel costs, printing and hiring. Our balance at the end of year was £2280.

Stephen then gave an overview of the SCoS Budget 2024/25:

- Our future plans depend on how much we can raise.
- Community Cohesion Project and Sing for Sanctuary have raised our profile and enabled us to receive funding from the Postcode Lottery and potentially other sources.
- We have been using LocalGiving to raise donations, and are now looking into Easyfundraising and LottoAbertawe.
