1. Welcome and Apologies

Tom Avery (Co-Chair) welcomed everyone to the meeting.

Tom explained the reasoning behind our call for a Special General Meeting, which is required because Swansea City of Sanctuary is now registered as a Charitable Incorporated Organisation (CIO, Charity Number 1214503). Members will be asked to vote to dissolve the 'old' Swansea City of Sanctuary association and to approve the transfer of all activities, assets, and memberships to the new Swansea City of Sanctuary CIO.

Questions were taken from attendees:

- One Member asked why SCoS decided to become a registered charity. Tom and Stephen Richardson (Treasurer) explained that one key reason is that charity status allows the organisation to access additional funding opportunities.
- One Member raised a question regarding restrictions on campaigning. Tom clarified that while charities cannot support political parties, campaigning and raising awareness are explicitly included in the charity's objects and will continue as part of our work.

2. Resolutions

The Resolutions were circulated to Members prior to the meeting. Tom invited Members to vote:

1. To dissolve Swansea City of Sanctuary (unincorporated association) in line with our 2012 constitution.

Members accepted this resolution unanimously.

2. To transfer all remaining assets to Swansea City of Sanctuary CIO (Charity number 1214503).
